#### Fingerprints / Back-ground Checks

Individuals applying for licensure for professions that require fingerprints must submit to a criminal back-ground check and provide evidence of fingerprint processing from a fingerprint vendor licensed by the Department. Fingerprints must be taken within <u>60 days</u> from the date that the application is submitted to the Department or the Department's testing vendor.

#### **Social Security Number**

APPLICANTS who state they cannot obtain a social security number must complete the affidavit form at the link below:

This is not a temporary SSN card, meant to replace the SSN# nor an application to obtain one.

When applying by paper use the 999# provided to you by Continental Testing.

Once a SSN card is received you have 10 days to provide proof of to the Department. If you can not obtain a SSN card by the time your license is up for it's first renewal you can submit another SSN Affidavit with the renewal application.

#### **Temporary License**

Foreign Graduates can apply for the temporary license if they meet the following criteria...

- Must have applied for the license
- Has fingerprinted
- Foreign credential documents. NO temp is issued without it, we must verify education.
- Paid the fee (License 50 / Temporary extra 25)

- CES Report, from one of the following: TruMerit (ask for full report), ERES, Josef Silny, The Evaluation Company, or IEE
- TruMerit Certificate
- TruMerit Visa Screen Certificate
- JS&A Visa4Nurses Certificate

An English test is not required as long as you took and passed the NCLEX Exam.

#### Other related information :

When applying to take the Nclex Exam use the exact same name on both CTS (Continental Testing Services) and Pearson Vue applications. Refugees can contact the Department for an affidavit if necessary to show variations on a name are one and the same person.

Use your personal email NOT your recruiter's. All communication will go through the applicant and can not go through a third party.

Acceptable ID/ Proof of name change:

- Marriage license
- Court Order
- U.S. Passport
- Real ID driver's license
- Real ID state ID card
- Divorce decree it must include:
  - 1<sup>st</sup> page of decree
  - the page that indicates the name change
  - o judges signature page

An application (by exam) is good for 3 years after which you have to restart if you have not completed the licensing process.

A Mini App or "Pass Letter" is provided by CTS not IDFPR... the 50 USD Fee can be mailed in or you can process the payment online at <u>IDFPR | Online Payments for Paper Applications</u>. The mini app does not need to be sent in if payment is through EPay. Retain a copy of the EPay confirmation receipt in case there is an issue.

An Athorization To Test letter (ATT) – is good for 6 months. There are no extensions past the test date. You can reschedule 24 hours **prior** with CTS if necessary.
